CANDIDATES OPPOSED TO HEATHROW EXPANSION

JACK RANKIN (CON, WINDSOR)

I do not believe that further expansion at Heathrow is the right choice for Windsor or the UK. We need a better not bigger neighbour. The effect that a 3rd Runway would have on quality of life for residents in our area cannot be understated.

SARAH OLNEY (LIB DEM, RICHMOND PARK)

I am fully opposed to the 3rd Runway. Its economic benefits are overstated, thousands of households will be subjected to aircraft noise for the first time, and expansion of one of Europe's heaviest polluters in a climate crisis pushes us ever further away from Net Zero.

DANNY BEALES (LAB, UXBRIDGE & SOUTH RUISLIP)

Labour has long been clear that any airport expansion must pass our tests on air quality, noise pollution, delivering countrywide economic benefits and enabling us to meet our obligations on climate change. Labour will continue to judge any future proposal for Heathrow airport expansion against the same tests.

GREG HANDS (CON, CHELSEA & FULHAM)

Since my resignation from the Government six years ago in 2018, Heathrow Airport still does not have a third runway. I have always stood up for constituents and I will continue to fight against Heathrow's expansion, and against night flights.

MONICA HARDING (LIB DEM, ESHER & WALTON)

There are many parts of Esher and Walton constituency that are blighted by noise from Heathrow - particularly night flights - so I am well aware of the impacts a 3rd Runway would have on our local community.

ANDY SLAUGHTER (LAB, HAMMERSMITH & CHISWICK)

I am totally opposed to a third runway at Heathrow, a position I have maintained for over 40 years in politics in west London. I am delighted the Labour Party has moved its position to one where the 4 tests make it impossible in my view for Heathrow to persuade a Labour government to allow the development.

DAVID SIMMONDS (CON, RUISLIP, NORTHWOOD & PINNER)

I have long opposed the expansion of Heathrow both as MP and Deputy Leader of Hillingdon Council. The expansion of Heathrow has been marketed as expanding UK PLC, but in fact it does the reverse. Parliament needs to get to grips with the true impact of expansion and ensure the Government cannot not force it through.

HARRY BOPARAI (LIB DEM, SPELTHORNE)

As a Heathrow airport worker for over 30 years, I strongly oppose a 3rd runway for a number of reasons therefore you have my full support. I will not be supporting any 3rd runway and if elected will support the campaign as required.
